

## ACADEMIC HEMATOPATHOLOGIST

The Department of Pathology and Molecular Medicine at Queen's University invites applications for the position of academic Hematopathologist with training/expertise in Lymphoma Pathology.

**Qualifications.** Qualified applicants will hold an MD degree (or equivalent). Candidates must be eligible for medical licensure with the College of Physicians and Surgeons of Ontario and must hold Royal College of Physicians and Surgeons of Canada certification or American Board of Medical Specialties in Hematological Pathology or Clinical Pathology. Appointment will be at an academic rank commensurate with experience.

**The Department.** We are a very collegial department, with a strong culture of scholarship. The expectation of the successful appointee will include participation in hematopathology services including review and sign out of blood film, bone marrow, flow cytometry and lymphoma pathology cases. The ability to participate in additional services such as hemoglobinopathy interpretation, hemostasis sign out and transfusion medicine support would be an asset. We are an academic health sciences centre with a full Hematology/Oncology service, including both adult and pediatric care, as well as providing hematopathology support for regional hospital laboratories. We have built a very strong hematopathology division with expertise and leading edge advancements in malignant hematology diagnostics including flow cytometry and molecular analysis. Although primarily a clinical position, a strong potential for and/or experience in innovative scholarly research or quality improvement would be an asset with the expectation that the candidate will also participate in collaborative research that would mesh with ongoing activities in the Division of Hematopathology and the larger Department of Pathology and Molecular Medicine. Demonstration of a strong potential for teaching contributions in the Department's undergraduate, graduate and residency training programs will also be expected.

**Compensation and protected time.** There is potential for flexibility in the balance of service and academic time commitments for this position. The minimum compensation for pathologists in Ontario is \$383,000 (CAD) per year.

Faculty and their dependents are eligible for an extensive benefits package including prescription drug coverage, vision care, dental care, long term disability insurance, life insurance and access to the Employee and Family Assistance Program. Employees also participate in a pension plan. Tuition assistance is available for qualifying employees, their spouses and dependent children. Queen's values families and is pleased to provide a 'top up' to government parental leave benefits for eligible employees on maternity/parental leave. In addition, Queen's provides partial reimbursement for eligible daycare expenses for employees with dependent children in daycare. **The successful candidate** will provide evidence of an ability to work in an interdisciplinary, collaborative environment. Applicants should demonstrate strong potential for outstanding teaching contributions in the department's undergraduate, graduate, and residency training programs. We will further prioritize a track record of and potential for improving the practice of pathology through research, education, quality improvement, or clinical innovation.

The successful incumbent will be expected to provide 70% clinical services and 30% teaching / research (to be divided based on departmental need and personal interest at the time of hiring). The expectation of services is 45 hours/week for 45 weeks/year and participation in pathology on call services.

**Kingston Health Sciences Centre** is southeastern Ontario's complex, acute and specialty care, research and teaching hospital. Fully affiliated with Queen's University, the hospital is ranked as one of Canada's top research hospitals. Applications that do not include this information will be deemed incomplete.
